Debbie's Dream Foundation: Curing Stomach Cancer (DDF) is hosting our fifth annual **DDF North Carolina Golf Tournament and Charity Dinner** on Saturday, November 3, 2018 at the Gates Four Golf & Country Club in Fayetteville North Carolina. Tony Leonard was diagnosed in 2012 with stomach cancer when he was only 39 years old with five young boys. At that time Tony and Christy Leonard connected with DDF and became the North Carolina East Chapter Founders. Tony's middle son wrote Senator Richard Burr to help support his Daddy's fight. This past March, Tony suffered a relapse and his cancer has returned. North Carolina has been greatly affected by stomach cancer. North Carolina lost State Senator Martin Nesbitt ten short days after his stomach cancer diagnosis; Richard Tuttle passed away at age 34; Susan Reid mother of three passed away at 49; and there are many others. Stomach cancer not only takes lives, but for those who survive, it could mean life without a stomach, chronic pain, toxicity, and other complications.

DDF was founded in 2009, one year after its founder, Debbie Zelman, was told that she had stage IV advanced, incurable stomach cancer. When Debbie was diagnosed, she was forty years old, married to a physician, the mother of three young children, and a practicing attorney. Upon diagnosis, Debbie's chances of being alive in five years were four percent. There were - and still are - few treatment options for this devastating disease, and no progress has been made in survival rates. While she has fought for her own life, Debbie also tried to educate the public and help other stomach cancer patients change their odds. DDF is a 501(c)(3) non-profit organization dedicated to raising awareness about stomach cancer, advancing funding for research, and providing education and support internationally to patients, families, and caregivers. DDF seeks as its ultimate goal to make the cure for stomach cancer a reality.
