Specific Program Description/Proposed Language: The funds provided in the Peer Reviewed Cancer Research Program are directed to be used to conduct research in the following areas: ...stomach cancer...

Explanation/Rationale: We request that you support the continued inclusion of stomach cancer as a disease eligible for research funding through the Department of Defense's (DoD's) Peer Reviewed Cancer Research Program (PRCRP) in the FY2026 Defense appropriations bill. The PRCRP was established in 2009 and supports military relevant research into specifically designated cancers. Stomach cancer was first included in the PRCRP in FY 2015. Military service members are exposed to environments that put them at increased risk of certain cancers, including stomach cancer. A diagnosis of stomach cancer for the service member or for their family members impacts mission-readiness.

The Department of Veterans Affairs considers stomach cancer to be a service connected malignancy for service members who experienced hazardous exposure to ionizing radiation. Additionally, due to past and present deployments, service members and veterans may have an increased risk of stomach cancer, especially if diagnosed with *H. pylori*. Studies suggest the risk of *H. pylori* infection increases among military personnel during long-term deployment. This is significant because, according to the National Cancer Institute, infection with *H. pylori* is the primary identified cause of stomach cancer.

There are few effective treatments for stomach cancer and diagnosis often occurs at late stage. The PRCRP offers an important opportunity to study diseases like stomach cancer that are not well understood, have few treatment options, and for which military service confers a higher risk

Describe the project or program, what it will do and why it is necessary:

Congress added stomach cancer as a disease eligible for funding for the first time in FY 2015 and it was maintained as an eligible disease ever since. While the grant funding process is underway for FY 2024, nearly \$44 million has been awarded for stomach cancer research to date. DDF urges the continued inclusion of this devastating disease in this important program. Because this is a congressionally directed program, it is critical that members of Congress continue to show their support for keeping stomach cancer in the program.
